I/We also understand that YRH cannot guarantee the health of any animal available for adoption as they are strays from random sources and their medical background is unknown and that veterinarians have screened this animal before adoption but cannot guarantee it is not harboring any unknown illness. I/We agree to indemnify and hold harmless Yorkie Rescue Houston, its officers, Board of Directors, volunteers and/or staff from any injury, death, or damage caused directly or indirectly by dog.

I/We agree that the dog(s) will reside in my/our home, will be kept as a household pet, and will not be used for breeding, fighting or as a hunting or guard dog(s). I/We agree to provide this dog(s) with a safe home, proper care and attention, and humane treatment in accordance with all current and future state, county, and local laws and ordinances where I/we reside(s). I/We agree the dog is not to ride loose in the back of trucks, left unattended in a vehicle, is not to be chained or tied-out, allowed to run or roam loose and the I/we warrant(s) that the dog will not be contained solely by a hidden fence or electric fence. The dog is not to be solely an outside pet nor housed outside or in a kennel run. I/We agree that the dog will be indoors when I am/we are away from the home.

I/We hereby acknowledge receiving from Yorkie Rescue Houston ("YRH") the animal described herein and promise and agree to provide it the wholesome food, clean fresh water, safe shelter, identification and any and all necessary veterinary care. **If at any time I can no longer care for or keep this adopted animal, I agree to contact YRH first regarding its future.** YRH has the right to investigate the new home and to remove the animal if the home is unsuitable. I/We agree to assume full responsibility for the animal's behavior, health and care, and any possible damage done by said animal. Failure to comply with all the conditions of the contract may result in YRH reclaiming the animal.
